# Renting Kitchen Area and Paying for an Employee to supervise

the protection and security of facilities and equipment, this is a cost that should be added to the fair market rent. equipment purchased with revenues from food service and food service space maintained with federal funds, the district order and receive the item, this includes labor for cleaning and sanitizing the equipment. Regarding the use of any supplies, then the district will need to compensate the food services for the cost of the item plus the labor expended to will need to rent the facilities and equipment from the non-food service entity at their respective fair market value.
